(1) Terms of Payment stated on invoices from AIMS® and (2) Should customer fail to pay an invoice when due, Customer hereby agrees to pay month late charge of 2% per month of balance outstanding 60 days and over (3) No products can be returned without prior authorization by AIMS® (4) Customer agrees to pay \$25.00 handling charge on each returned check. Customer further agrees that, if any invoice is not paid according to its terms, Customer's account shall be deemed delinquent and subject to among other things: (1) Suspension of RMA privileges and (2) reevaluation of possible downgrading of credit terms. Applicant agrees to pay all costs of mediation, without limitation, cost of court and reasonable attorney fees. AIMS Power only accepts returns on AIMS Power branded products. All other brands our subject to their respective manufacturers. AIMS Power may, at its sole discretion, accept returns of non-AIMS Power branded products if AIMS Power sold the product and the product is unopened and brand new in new sellable condition.

(2) . Jurisdiction; Venue; Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Nevada (irrespective of its choice of law principles). The parties hereby agree that any suit to enforce any provision of this Agreement or arising out of or based upon this Agreement or the business relationship between the parties hereto shall be brought in federal or state court in Reno, Nevada. Each party hereby agrees that such courts shall have co-exclusive personal jurisdiction and venue with respect to such party, and each party hereby submits to the co-exclusive personal jurisdiction and venue of such courts.

TO RETURN MERCHANDISE:

OBTAIN AN RMA # FROM AIMS POWER DIRECT

1. All returns must have a RMA number for processing.
2. Packages without a RMA number on the outside of the package will not be accepted.

RETURN PACKAGING – Repack the product in its original packaging, along with all manuals and related materials. Place the packaged product in a protective outer box. The RMA number must be clearly marked on the outside box / package. Please Note: We must receive all original products in order to process your return or exchange. AIMS Power is not responsible for products that are damaged due to poor packaging or lost shipments. Remember to keep your Tracking Number.

RETURN SHIPPING CHARGES – The customer is responsible for shipping charges on returned products; AIMS will send replacements via Ground freight at no charge. We recommend shipping via ground.

RETURN SHIPPING METHOD – AIMS Power strongly recommends you fully insure your return shipment in case it is lost or damaged in transit. We also recommend you use a carrier that can provide you with proof of delivery for your protection. Remember to keep your Tracking Number.

RETURN PRODUCT PACKAGING – It is the customers responsibility to make sure the returned merchandise is properly packaged and protected for shipping. We recommend you insure your package for the purchase value.

PRODUCT DAMAGED IN TRANSIT – If your product arrived DAMAGED in transit, it is best to REFUSE it back to the carrier attempting delivery. Please inform AIMS Power of the refusal. If you accept the package, make sure it is noted on the carrier's delivery record in order for AIMS Power to file a damage claim. Save the merchandise and the original box and packing it arrived in; notify AIMS Power immediately to arrange for a carrier inspection and pick up of the damaged merchandise.

RETURNED PRODUCT CONDITION: LIKE NEW CONDITION – All returned products must be returned 100% complete, including all of its components, all original boxes and packing materials, manuals, blank warranty cards and other accessories provided by the manufacturer.

INCOMPLETE, SCRATCHED or DAMAGED CONDITION – AIMS Power reserves the right to refuse crediting the customer's account and the product will be returned to the customer.

DEFECTIVE PRODUCT – After 30 days, defective product may be returned for repair or exchange only, at AIMS's option. **OUT WARRANTY OR NON-DEFECTIVE PRODUCT**- Any Product that is returned and deemed to be of working condition or out of warranty the customer is responsible for return shipping back to their location,

MAP POLICY

Purpose

AIMS Power has built a brand recognized for quality and value since 2001. This Minimum Advertised Pricing (MAP) policy protects that brand value by ensuring fair competition among our authorized resellers. When resellers advertise products below MAP, it erodes brand value perception and eliminates legitimate retail competition, particularly given the internet's global reach.

This policy allows consumers to choose resellers based on service, support, and loyalty rather than solely on advertised price. By becoming an authorized AIMS Power reseller, you agree to comply with the terms outlined below.

What MAP Controls

MAP Pricing

- Minimum Advertised Prices are provided in the AIMS Power Price Sheet
- MAP prices are lower than the Manufacturer's Suggested Retail Price (MSRP)
- AIMS Power may adjust MAP pricing at its sole discretion and notices will be communicated
- International resellers must convert MAP to local currency using current exchange rates

Where MAP Applies

Covered Advertising Channels

This MAP policy applies to all forms of public advertising, including but not limited to:

- **Print Media:** Flyers, posters, coupons, mailers, inserts, newspapers, magazines, catalogs
- **Digital Media:** Websites, online marketplaces, social media, mobile apps, email marketing (to non-customers), banner ads, paid search ads
- **Broadcast Media:** Television and radio advertising
- **Physical Signage:** Outdoor advertising, billboards, storefront displays visible from outside
- **E-commerce Platforms:** Company website, Amazon, eBay, Walmart Marketplace, and all other online marketplaces
- **Social Commerce:** TikTok Shop, Facebook Marketplace, Instagram Shopping, and similar platforms

Online Marketplace Rules

Auction Sites (eBay, etc.), Refurbished or Used Products are Excluded:

- "Buy It Now" prices must be at MAP or higher
- Auction starting bids and reserve prices must be at MAP or higher
- "Best Offer" options are prohibited
- Standard auctions without reserves or "Buy It Now" must open at MAP

Bundling and Promotions

You may not include free or discounted products (AIMS Power or other brands) with MAP products if doing so effectively reduces the advertised price below MAP. Example: Advertising "\$500 gift card with purchase" when the product is at MAP would violate this policy.

Competitive Pricing Language

You may advertise:

- "Lowest prices guaranteed"
- "We'll beat any competitor's price"
- "Call for price" or "Add to cart to see price"
- Similar competitive messaging

Requirement: The actual advertised price shown must still be at or above MAP.

Intellectual Property

All AIMS Power trademarks, copyrights, and marketing materials remain the property of AIMS Power. Use advertising materials only as authorized and in compliance with brand guidelines.

AIMS Power Sales Events

When AIMS Power runs promotional sales, the MAP will temporarily adjust to match the sale price for specified products and dates. You will receive advance notice with complete details.

Compliance and Enforcement

Your Responsibilities

- Ensure all advertising complies with current MAP pricing
- Train your staff on MAP requirements
- Monitor your advertising across all channels (including third-party marketplaces)
- Respond promptly to any MAP compliance inquiries from AIMS Power

Violations

Intentional or repeated violations may result in:

- Warning notice
- Temporary suspension of product supply
- Termination of account

AIMS Power reserves the right to take action at its sole discretion, with or without prior warning.

Unilateral Policy

This is a unilateral policy established by AIMS Power. We will not discuss or negotiate this policy with resellers collectively or individually, except for written approvals as outlined in the Exceptions section above.
